I hereby certify that I have adequate insurance to cover any injury or damage I may cause or suffer while participating in these activities or alternatively I agree to bear the cost of such injury or damage myself. I further certify that I have no medical or physical conditions, which could interfere with my safety in this activity. I assume and bear the cost of all risk that may be created, directly or indirectly, by any condition disclosed or undisclosed herein.
- 5. I hereby certify that I am at least 18 years old, or the part or legal guardian of the participant under 18, and I agree I will wear a batting helmet at all times while in the batting tunnels. I hereby provide TRG permission to administer basic first aid and I authorize TRG or its agents or employees to contact 911 or other emergency personnel as needed.

I do hereby give TRG its assigns, licensees, and legal representatives the irrevocable right to use photographs or video in all forms and media and in all manners, including composite, for advertising or marketing for publication or any other lawful purposes, and I waive any right to inspect or approve the finished product, including written copy, internet, etc., which may be created in connection therewith.

By clicking below, I acknowledge that if anyone is hurt, or property is damaged during my participation in this activity, a court of law may find me to have waived my right to maintain a lawsuit against TRG and each of the parties listed in Paragraph 3 above on the basis of any claim from which I release herein.
